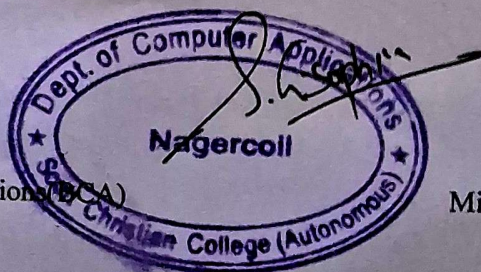

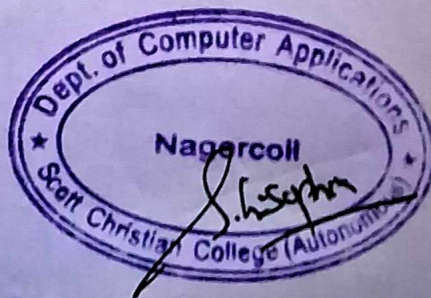

The meeting started with a Prayer by the Chairperson Dr S. Gnana Sophia. In the beginning, she introduced and welcomed the members present.


